# PHOTOGRAPHY & SOCIAL MEDIA POLICY

1. Purpose of the Policy

The purpose of this policy is to protect the privacy, dignity, and safety of children by setting out clear guidelines on the collection, use, storage, and sharing of photographs and videos of minors across media and social platforms. This policy applies to all staff, volunteers, contractors, and third parties working with or on behalf of Quick Feet Coaching.

### 2. Legal and Ethical Considerations

- We recognize our responsibility under laws including:
  General Data Protection Regulation (GDPR) EU/EEA
  Children's Online Privacy Protection Act (COPPA) U.S.
  - Local safeguarding/child protection laws

Under GDPR, photographs and videos of children are considered personal data and require explicit, informed consent from a parent or legal guardian.

#### 3. Consent Requirements

- We will only capture or use photographs/videos of children if:
  Informed consent has been obtained from the child's parent or legal guardian
  The child is informed (where age-appropriate) and their wishes respected
  Consent is freely given, specific, informed, and unambiguous

How Consent is Collected

• Via a written or digital consent form, signed by a parent/guardian Consent can be revoked at any time by contacting Brendan Lightfoot

4. Use of Images and Videos
Photos and videos may be used for:

- Educational purposes
  Internal documentation and progress records
- Newsletters and reports
- Marketing materials (with consent)
- Organization's official website and social media accounts (with consent)

#### We will not:

- Use a child's full name alongside their image
  Share images with third parties without specific consent
  Tag or identify children on social media platforms

### 5. Social Media Guidelines

- Only authorized staff may post content to official channels
  Content will be reviewed for appropriateness and sensitivity
  We will never share or repost content from a child's or parent's personal accounts without consent
- Comments on posts may be monitored and moderated to prevent inappropriate engagement

- 6. Storage and Security
  All media is stored securely with restricted access
  Files are encrypted where appropriate and only retained for as long as needed
  Unused or outdated media will be deleted or anonymized

#### 7. Child Refusal and Right to Opt-Out

- Children who do not wish to be photographed or filmed will be respected at all times
  Staff are trained to identify and honor opt-out requests during activities and events
  Children will not be disadvantaged in any way for refusing consent

#### 8. Events and Group Settings

- At public events, we will display clear notices stating that photography/filming may occur
- Where children are photographed in group settings, efforts will be made to avoid identification
- If consent was not given, the child will be excluded from media or blurred in group photos

#### 9. Breach of Policy

Any violation of this policy may lead to disciplinary action, including termination of employment or volunteer roles, and may be reported to relevant authorities.
